## MTP 1971 Amended in December – 2002 Guidelines

- To provide MTP services in safe and hygienic manner and to provide abortion services legally to prevent illegal abortions in any place and in turn to prevent maternal morbidity & mortality related to abortions.
- All the Hospital / Maternity Home including BMC /Private / NGO must register their place under MTP Act if Medical Termination of Pregnancy or even if D & C for incomplete abortion cases is performed.
- To provide legally MTP in safe and hygienic manner by qualified RMP as prescribed in the act under the specified conditions mentioned under the Act.
- ➤ No MTP to be done in any place without registration under MTP Act 1971.
- No MTP to be done by any medical practitioner, who is not qualified or trained, certified and registered under the Maharashtra Medical Counsel.
- No MTP to be done without taking consent of patient in form "C" as per MTP Act.
- ➤ For "Minor" or "Mentally ill" guardian consent to be taken in form "C".
- For MTP up to 1<sup>st</sup> trimester up to 12 weeks opinion of one Registered Practitioner and for 2<sup>nd</sup> trimester pregnancy opinion of two registered Medical Practitioners to be taken along with signature of concerned surgeon to be taken in Form I.
- For all MTP cases admission register as per format of Form II under the MTP Act to be maintained.
- In the OT register serial number of Form II to be mentioned to maintain confidentiality of the patient.
- No MTP to be done for sex selection purpose which is prohibited and punishable under the Act.

## Various forms and records to be maintained.

A- Application formB- Registration CertificateC- Consent form

- ▶ Form I Opinion of Medical Practitioner with list of Indication for MTP.
- Form II to be maintained for keeping the day-to-day Line list & data collection in given format.
- ▶ Form III Admission register to be maintained as per format.
- Monthly report as per Form II to be submitted by each centre to MOH by 2<sup>nd</sup> of month.
- Display the original MTP registration certificate in waiting area of the hospital.
- Display qualification certificate and MMC registration certificate of the Surgeon /Anesthetist / Assistant doctor as per registration.

## **Procedure for application**

Apply for New registration in form "A" and modified "A" form along with following documents in duplicate file.

- 1. Qualification certificate of Surgeon / Anesthetist / Assistant
- Maharashtra Medical Counsel (MMC) Registration certificate of Surgeon
  / Anesthetist / Assistant
- 3. Undertaking on Plain paper stating that MTP will not be performed by the centre or surgeon till centre is registered by surgeon / Anesthetist / owner of hospital..
- Certificate of Blood Bank for provision of blood in case of emergency, Blood Bank certificate to be attached.
- 5. List of equipments / emergency drugs.
- 6. Bio-medical Registration under MPCB copy.
- 7. Nursing Home Registration copy.
